Presentations cannot be used to market products or services and must be free from commercial bias. As we are still in the early stages of organizational growth, we unfortunately cannot waive the registration fee for presenters. Presenters shall be responsible for all expenses including registration, accommodation, and travel. Presenters are encouraged to apply for scholarship funds if needed. The scholarship application can be viewed here. If selected, the presentation must not be presented at any other industry event within the same calendar year. The final presentation will correspond with the original session description. All final presentations will be submitted to our review process and if they do not comply with all conditions your presentation will be removed from the program. All speakers must provide NOAH with a copy of their presentation (proprietary information can be removed) to post online for attendees to download. We will not be producing printed or CD proceedings or handouts.
